## Terms & Conditions – Viking Heliskiing

Please read through the following Booking Conditions prior to submitting your Booking Request.

I hereby apply to book one of the Viking Heliskiing (also referred to as VH) tour as specified in the following terms and conditions which I understand and agree to:

1. When paying a deposit I have entered into an agreement with Viking Heliskiing ehf., a limited liability Company registered in Iceland.
2. When you make a booking and pay your deposit, we will reserve your place on the basis of these Conditions. Your booking will be taken as confirmed in respect of all persons named on your booking.
3. All rates and deposits are in Euros, and an allowance will be made for exchange if payment is in another currency.
4. I enclose herewith my initial non-refundable deposit of EUR 2.000 per person for each multiday-trip that I am applying to book. A non-refundable deposit is required within 2 weeks of the reservation date for confirmation.
5. Full payment for all helicopter ski tours is due and payable ten (10) weeks prior to the commencement of the ski tour(s) applied for and all payments are considered as deposits.
6. In the event of a cancellation, the cancellation must be confirmed in writing through email – [info@vikingheliskiing.com](mailto:info@vikingheliskiing.com).
7. If a cancellation request is received less than ten (10) weeks before the trip commencement, and if I or VH can find a replacement for the trip booked, all funds will be transferred to the replacement.
8. If a cancellation is received by VH less than ten (10) weeks before the trip commencement and I cannot find a replacement for the trip booked, the total of all deposits will be retained by VH and are non-refundable.
9. If cancellation is received by VH more than ten (10) weeks before trip commencement, VH will only retain the amount of the non-refundable deposit.
10. A reservation will be cancelled immediately if VH has not received a full payment by ten (10) weeks prior to the commencement of the ski tour.
11. If you are unable to attend to your booked trip, you have paid the trip in full and the final payment date has passed, then the ski package is transferable to next season.
12. If we need to cancel your trip (for example as a result of adverse weather or snow conditions) we will notify you as soon as possible. In the event of cancellation, we will endeavour to rearrange the dates of the trip. In case we are unable to find suitable dates for the trip, we will refund all the money you have paid.
13. I will not be permitted to participate in any VH trip unless a "Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement" is properly signed and witnessed. Our multi-day skiers have the opportunity to complete this

form and send the signed form to Viking Heliskiing by email (info@vikingheliskiing.com) or sign the waiver when they arrive to our skiers lodge in Thvera. Day-skiers can sign the waiver in the morning of registration. Please review the Sample Waiver Form on our website. Refusal to sign this waiver will result in cancellation of the respective ski package with no refund of any sort.

14. It is understood and agreed that it is my responsibility to arrive at the required time and location to commence any trip.
15. VH reserves the right to cancel any ski package at any time. Full refunds will be given in this case.
16. Note for group organisers - The group organizer is responsible to ensure that all guests are fully aware of VH Terms and Conditions. The group organizer is also responsible for making sure that payment deadlines are met.
17. All participants under 18 years must have written documents from parents or legal guardian that they are allowed to attend the booked tour and that their participation is in accordance with VH terms and conditions.
18. It is mandatory to ski with transceivers, probes and shovel while skiing with VH.
19. Photo Release - I give permission to Viking Heliskiing to use photos of me for marketing and promotional purposes.
20. Prices are subject to change at any time. A fuel surcharge may be applied to any of the heliskiing package in the case of considerable increases in fuel prices.
21. We reserve the right to alter prices shown in any of our marketing literature or on our website and we will inform you of any price changes at the time of booking.
22. Prices for heli-skiing are usually based on us being able to take a party of 4 on each trip. Where your party consist of less than 4 persons (or a multiple thereof) then we will endeavour to sell other places on the trip to others. Where this is not possible then we reserve the right to make an additional charge or otherwise alter the trip to take into account the shortfall in participants.
23. We hope and expect to be able to provide you with your booked trip. On occasions, changes do have to be made and we reserve the right to make these.
24. If less than the guaranteed amount of flying time have been reached we will refund you/your group EUR 1.850 per hour of unused time (divided to group members). Refunds are given only if a person gets less than the guaranteed amount of flying time due to inclement weather, avalanche hazard or breakdown of equipment. We do not refund guests who do not reach their guaranteed amount of flying time due to poor skiing ability, fitness or injury. If you decide to come in early or not ski at all, no refund will be issued should the guaranteed flight time not be reached.
25. Heliski packages are sold in units, therefore no refund is issued if there is no skiing on certain days because of inclement weather or helicopter breakdown. No refunds are issued in whole or in part for unused days within the package due to late arrival or early departure.
26. By its very nature, off-piste and heli-skiing require a significant degree of flexibility on your part. Whether or not a trip can proceed as planned or at all, is largely

dependant on weather and snow conditions. In these circumstances, changes or cancellations can be made at the last minute. Our guides and pilots have absolute discretion as to whether to determine if a trip (or any part of a trip) can proceed or continue and you will be expected to comply with their instructions.

27. We will need full details from you of any illnesses, medications currently being taken, known medical conditions and allergies. This information is required purely to assist in the case of an emergency and will otherwise be kept strictly confidential.
28. We will not be liable to pay any compensation if we are forced to cancel or in any way change a trip as a result of unusual or unforeseeable circumstances beyond our control, the consequences of which could not have been avoided even with all due care. These include bad weather, adverse snow conditions, unavoidable technical problems with transport, war or threat of war, civil strife, industrial disputes, natural disaster, epidemic or terrorist activity.
29. We both agree that any dispute, claim or other matter of any description (and whether involving personal injury or not) which arises out of or in connection with your booking or travel must be brought in the Courts of Iceland only. We both also agree that Icelandic law (and no other) will apply to your contract. If this provision is not acceptable to you, you must tell us at the time of booking.
